WHITEHALL CITY COUNCIL MEETING

MINUTES – June 6, 2023

President Potter called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, June 6, 2023.

At President Potter's request, everyone rose for a moment of silence. Those assembled then recited the Pledge of Allegiance.

APPROVAL OF MINUTES:

Colin Finan, 652 Greenwood Rd, Whitehall, OH thanked Council and the Administration for continuing the Home Reinvestment Program this year. He has lived in Whitehall for five years and he had a question about the lottery component. He could not find this on social media or the website.

City Administrator Woodruff addressed Mr. Finan's questions and apologized for the lack of clarity on the program being a lottery and not a first come, first served program.

OFFICIALS' REPORTS

Mayor Kim Maggard – she thanked Mr. Finan for coming out and that it is always good to receive constructive feedback. They are looking forward to acknowledging a fine young man during this evenings meeting.

City Administrator Zach Woodruff – he had no official report but asked that Kelsey Miller be given a few minutes to update Council on some legislation coming their way.

Economic Development Manager Kelsey Miller gave a brief overview of the draft municipal income tax reimbursement agreement with Company Ethiopian Tewahedo Services to be located at 4300 East Broad Street. The President and CEO of Ethiopian Tewahedo Services Dr. Seleshi addressed Council as well.

City Attorney Michael Bivens – in the month of May, the City Attorney's Office prosecuted in Mayor's Court two hundred eighty nine cases with only thirty-one of them committed by Whitehall residents. That is about ten percent. Overall cases combined with Municipal Court was four hundred thirty four cases with sixty-five committed by Whitehall residents. That is about fourteen percent overall. The data is actually lower than this time last year.

City Auditor Steve Quincel – he had no official report. He asked for favorable consideration on Ordinances 038-2023 and 039-2023 and Resolution 022-2023.

Public Safety Director Van Gregg – was not present.

Treasurer Shaquille Alexander—he had no official report. He asked for favorable consideration on Ordinances 038-2023 and 039-2023.
