**Annualize Installment Method Not Permitted.** The Whitehall City Codes do not allow for calculating estimated tax payments based on "annualized income installment method". The Whitehall City Codes (184.07) requires that each estimated tax payments "be accompanied by a payment of at least one-fourth (1/4) of the estimated annual tax: and that a declaration of estimated tax which is less than 90% if the tax shown on the final return shall not be considered filed in good faith. Thus, even if your business is seasonal, City estimated tax payments must be based on estimated annual taxable income.
